SUBSCRIPTION RETAINER MODEL FOR THE UNIVERSITY OF SALFORD

RAB were approached by the University of Salford in early 2019 with a view to building upon their existing BC framework. Specifically, they wanted to strengthen their position, drive consistency, and ensure alignment with industry best practice.

After a comprehensive review of their objectives and available resources, it was agreed that establishing a monthly subscription-based service level agreement (SLA) would deliver the best outcomes across the whole university.

This was the first time that RAB had implemented a retainer model for a client, but it represented the best solution and was therefore worth the investment. The university benefited from a complete top to bottom integration of the very latest BC practices, as well as the reassurance that RAB experts were on hand should a need for immediate support ever arise.

The project went live in 2019 and was quickly put to the test with the unexpected arrival of the COVID-19 pandemic. Suffice to say the university was in an excellent position to implement their improved BC plans, and also draw on the expertise of RAB as and when required.
